With gratitude we pay our respects to the land, the people and the communities that contribute to what today is known as the State of New Mexico.





Distribution of Medicaid BH Providers Across NM

- Growth of 103% since 2017
 - 66.2% Urban
 - 31.8% Rural
 - 1.9% Frontier

What are the problems with BH workforce?



- Too few practitioners
 - Don't look like New Mexico
 - Not well prepared for practice in the publicly funded system of care
 - Provide 'extra' services
- Relatively weak provider network
 - Chronically underfunded
 - Razor thin margins
- Quality questions

- Expand definition of BH workforce
 - e.g. For Mobile Crisis Teams: A licensed Mental Health Therapist; Certified Peer Support Specialist; Certified Family Support Workers; Community Support Worker; Community Health Worker; Community Health Representative; Certified Prevention Specialist; Registered Nurse; Emergency Medical Service provider; LADAC or CADAC; non-independently licensed behavioral health professionals; Emergency Medical Technicians; Licensed Practical Nurses; Home visitor; Licensed Substance Abuse Associate; Other certified and/or credentialed individuals
- NLBHA Scholarships; WICHE Psychology Internships; Peer Scholarships
- Free Undergraduate Education
- GME Expansion Psychiatry
- Primary Care Council
- Legislative funding for Social Work Chairs
- ECECD Mental Health Consultants
- Retention Bonuses
- DOH Health Professions Recruitment
- Bilingual Certification; BH Interpreters
